I. Financial Report 2015-2016 Budget

a. Charter School Institute Conference Report

Kristen Stone attended the Charter School Institute Conference. From the conference she learned some items that we will need to complete for renewal of our charter. We are in our third year as a Charter School. Moving forward if we continue to show good financial data, good testing scores, and have a good performance framework we will be on track to get renewed for an additional 5 years. Over the course of this year we also need to get in place: Board Goals and Objectives for the next 5 years. These goals are in three categories 1) Academic, 2) Financial, 3) Operational. Goals need to be written in SMART format. The Charter School Association will interview teachers, parents, board members, students next year about the school. The school needs to clearly communicate the VISION of the school to everyone.

Performance Framework for next year should be better because we have resolved all items necessary and we will not be graded negatively for the two populations of students that we do not have enough students to show percentages.

Mike Anderson spoke at the Charter School Institute about general safety procedures. Kristen Stone will contact him this week about setting up a training for our teachers about lockdown procedures. This is a two hour training offered for free.

The chairman of the Board of Education spoke at the conference and spoke in favor of charter school.
